### Briar Middle School Dual-Sport Participation Policies and Procedures

*In order for a student to qualify for dual-sport participation, he/she must meet the following criteria:*

1. Must declare his/her intent in writing to the Briar Athletic Director prior to the start of official beginning of the earliest season. (Formal email is acceptable)
2. Must have parental consent, in support and acknowledgement of agreement and any decisions made by the coaches or athletic director to resolve any potential conflicts.
3. Must have written consent from both coaches, acknowledgement of agreement.
4. Students and/or parents must declare on this form which sport will take precedence in the event of a conflict in scheduling of practices or events (**declare a priority sport**).
5. PRIORITY SPORT MEANS: A.) If games, tournaments, or events take place on the same day, the priority sport takes precedence. B.) Practice schedules, meetings, or other non-competition activities should be balanced as best as possible. It will be important for coaches, parents, and athletes to work together to create a cooperative practice schedule that serves both teams.
6. Must maintain a minimum 2.0 GPA prior to, and during the 9 weeks sports take place.
7. The priority sport will be charged the \$50.00 Briar athletic fee (if applicable), athletes will be listed in the secondary sport for roster verification purposes.
8. If the student-athlete breaks the dual-sport contract by not honoring a Priority Sport commitment, he/she may face consequences from administration or head coach.
9. If a conflict arises between any of the involved parties, the athletic director shall have final say in resolving any pending situations.
10. *Signatures are required on the next page.* Student, parent, both coaches of listed programs, and athletic director must sign in acknowledgement and agreement with the Briar Middle School dual sport policies. *Please see the next page:*
